GATE FEES/TIME: Open @ 6AM Sunday morning \$10 per rider—\$10 per spectator

SIGN UP: Open Saturday @ 3PM to 6PM—Sunday @ 6AM to 9:30AM—Fill out entries prior to the race date online at

RACE ENTRY FEES: \$35 for 1st race—2nd & 3rd entries \$30

MINORS: Must have parent or legal guardian with NOTARIZED RELEASE FORM present to complete the signup process. There will be a Notary Public available at signup.

AMA—DISTRICT—SERIES MEMBERSHIP: AMA MANDATORY, & will be present @ signup. NO District cards or Series Membership Required.

PRACTICE TIME: NO PRACTICE SATURDAY—Practice starts 'BY CLASS' @ 8AM to 9AM (*or when ambulance arrives). Last lap practice 9:15AM—EVERYONE. You must complete sign-up prior to the first scheduled practice—NO EXCEPTIONS. Start will be @ 9:30AM

NUMBER ASSIGNMENT: We do not assign numbers. Numbers are what you have on a first-come, first-serve basis. You may run whatever numbers you wish unless a rider has previously entered one of our series with the same number. You will then be asked to change or modify your number.

CLASSES: Three (3) riders are required to make a division. Pee-wee classes, mini classes, schoolboy, 250cc, OPEN VET 30+, SEN 40+, MAG 50+, MASGTER 60+, Women, Vintage, Classic, Evolution, Revolution, Sidehack and Quads. Number of entries will determine if some classes will be combined. Experience levels range from Beginner to Expert.

SERIES POINTS: Points will be earned based on the AMA rulebook. Top points finisher must complete a minimum of five (5) races in each competing division.

RACE DAY AWARDS: As this is a Benefit Event, Trophies awarded to 1st place riders only—100% Pee-wee trophies
